OPPORTUNITIES FOR PARTICIPATION:

- As an author of a scientific and professional paper (oral presentation)
- As an author of a scientific and professional paper (poster session)
- As an author of a round table discussion (technical-commercial presentation).

CONDITIONS OF PARTICIPATION:

All authors and co-authors are required to pay a registration fee amounting to € 360.

Organising a poster session is possible. If the paper focuses on commercial or promotional issues, it will be directed to a round table presentation, which is charged at a special price. The inclusion of a specific topic in the final program, as well as the sequence of the topics, will depend on the quality and number of accepted papers. The selection of papers will be based on a review of summaries by a special CGA working group.

We kindly ask all the authors to submit the following (no later than 20th December 2015):

- Title of the paper
- Full name of author (of the principal author)
- Full name(s) of co-author(s)
- Full name of the person presenting the paper (presenter)
- Company name, address, telephone number, fax number, author's e-mail address
- Company name, address, telephone number, fax number, co-authors e-mail address
- Title of the paper in English
- Extended text summary in English (1 page of text)
- Keywords in English.

SUBMISSION DEADLINES:

- **Title and summary submission: 20th December 2015**
- Notification to authors on acceptance of the paper: 20th January 2016
- Final paper submission: 20th February 2016
- PowerPoint presentation submission: 20th March 2016
